8. Eligibility Criteria

- a) The Firm/Agency must have at least 15 number P3 LED Screens of size 15x10 ft. each and sufficient Public Address equipments of reputed multinational companies to cater to the requirements for a public meeting of audience of 10,000 or more, to participate in the tender for empanelment. Firm/Agency must provide undertaking in this regard alongwith tender form, failing which tender shall be liable to be rejected.
- b) Experience of atleast 3 such installations in Government functions. Please attach work orders and satisfactory completion certificates in each case. In case completion certificates are not available, self attested satisfactory completion certificates may be attached.
- c) Firm/Agency should have an average financial turnover of 1 Crore rupees for the three financial years i.e. 2020-21, 2021-22 and 2022-23. Audited statements of

accounts or certificate of CA must be enclosed with the Tender Form for the said period.

Terms and Conditions for the Tender

- 1. The empanelment will be valid for the period of 2 year(s). However, the empanelment could be extended further on mutually agreeable terms.
- 2. The Technical and Financial Bids should be submitted in separate envelopes. The proforma given at Sr. No. 9 (a), 9(b) and 9(c) of tender form containing the rates to be quoted by the participating agency must be submitted in a sealed cover which shall be opened only in respect of agencies, those who qualifies technically as per eligibility criteria.
- 3. The firms/agencies who have already participated in the tendering process on 04th July, 2023 need not to attach the drafts towards the price of tender document as well as EMD.
- 4. Selection of the Firm/Agency for empanelment will be done on the basis of overall quoted rates for LED screens, LED TVs and its accessories, Equipments required for live casting of the function and Public Address System with accessories after qualifying technically. The Firm/Agency quoting overall minimum rates for all these components will be ranked as number one and so on and so forth. Preferences in empanelment will be given to the firm/agency that has quoted rates for all the three components, which in total has to be minimum. However, if none of the firm/agency quotes rates for all the components, then department may consider individual firm quoting for the each component, if quoted rates are minimum.
- 5. A panel of three Firms/Agencies will be made by the Department in order of rank. If the Firm/Agency ranked as number one refuses to execute the order, then it will be awarded to the number two ranked Firm/Agency and so on and so forth after negotiation of rates and security money to be deposited with the Department. However, in such case the security money of the Firm/Agency refusing to execute the work will be forfeited and the Firm/Agency may be de-empanelled for rest of the empanelment period.
- 6. Rental charges for LED Screen alongwith accessories and other equipments will be paid for two days (for the day of function and day of testing). No rental charges will be paid for the day of transportation. The Firm/Agency will have to install the LED Screen alongwith accessories and other equipments, 24 hours before the start of function and make it ready for testing. The Equipments may be required to be installed at any location in the State as per requirement.
- 7. The rates approved by the Department will be final for the empanelment period and no request for change in the rates will be entertained during the said period.
- 8. The installation and commissioning of the entire system/individual systems will have to be done on a two days notice of the Department. However, in emergent situations firm/agency empanelled at lowest rates with the Department shall be required to execute the work on very next day of the issue of release order. This condition also includes the work to be executed immediately on signing of Contract Agreement.

- 9. Applicant firms/agencies will be required to deposit an amount of Rs.5,00,000/- only as EMD which will be converted into security deposit for the entire term of contract for rank-I empanelled agency. Therefore Demand Draft of Rs. 5,00,000/- in the name of "Director, Information and Public Relations payable at Shimla" must be enclosed with the Tender Form in order to get empanelled with the Department.
- 10. The security money deposited with the department shall be forfeited in case empanelled firm refuses to execute the work order released by the department.
- 11. EMD draft of unsuccessful bidder or ineligible agencies will only be returned on completion of tendering process.
- 12. All the documents attached with the tender must be signed properly by the authorized signatory, failing which tender will be liable for rejection.
- 13. Conditional Tender will be rejected.
- 14. The Tenders must be submitted in a sealed envelope super scribing thereon "Bid for the Empanelment of Agencies for Hiring LED screens, LED TVs and its accessories, Equipments required for live casting of the function and Public Address System with accessories". This envelope should have two separate envelopes each one for the "Technical Bid" and "Financial Bid".
- 15. Payment on account of installation of the entire system/individual system will be released within 30 days of the receipt of final bills duly verified by authorities concerned.
- 16. The deduction from final bill submitted by the firm shall be made in case of delay in execution of work or if the execution of work by the firm is not at satisfactory level.
- 17. Director Information and Public Relations, Himachal Pradesh, Shimla-2 reserves the right to reject any or all the tenders without assigning any reason. Besides, if required, he also reserves the right to relax any of the condition/conditions of the tender.
- 18. The successful bidder must have capacity to arrange and install 100 or more LED screens throughout the State for a same function on the same day as and when so required.
- 19. No payment will be made for any non-functional LED Screens.
- 20. Actual transportation charges of the LED Screens incurred by the Firm/Agency will be paid on the rates fixed by registered Transport Union. The supplier will furnish an undertaking that the rates being charged are minimum. The Firm/Agency will be required to carry maximum possible number of Screens in a vehicle to the locations falling on the same route. However, at any time, if it is found that the Firm/Agency has charged excess fare, the Firm/Agency shall be liable for penal action as per the provision of Law and excess payments made shall be recovered.
- 21. The agency will have to supply equipments of desired specifications and make/model.
- 22. The agency is liable to keep sufficient spares at site during the event.
- 23. The agency has to arrange the Soundless (Noise free) Generator along with fuel for Operation at Stage.
- 24. The agency has to provide proper ground earthing for Generator/electrical equipments of sound and video at event premises.

- 25. It shall be the responsibility of the agency to arrange for manpower, material and necessary expertise for executing the work.
- 26. The agency must ensure the safety of their equipments during the events, the department will not be responsible for paying damages, theft of the equipment in any way.
- 27. Each activity/job has to be provided and made operational strictly as per specifications and schedule.
- 28. No subletting will be authorised. The agency will be the sole operator and responsible for operations.
- 29. The agency will supply a list before start of the VIP/VVIP event of its team members/employees showing their names, addresses and photographs for the purpose of issue of photo identity cards as well as for Police Verification. No substitution of the employees will be allowed except in emergent cases and that too with the prior approval of management in writing. Further, a list of its employees as well as the substituted/changed employees to be deputed for the event duty, showing their names, addresses and photographs has to be supplied for the purpose of Police Verification.
- 30. Each activity/job has to be provided and made operational as per specifications and schedule.
- 31. Smoking, consumption of liquor and chewing of tobacco etc. by the staff of the service providers are totally banned during events.
- 32. Child labour will not be permitted.
