ELIGIBILITY CONDITIONS:

- 1. The bidder agencies/ firms should have GST number and PAN.
- 2. The bidder should have an average annual turnover of Rs. 10.00 lakh (Rs. Ten Lakh Only) for last three financial years. Turnover details for the years 2021-22, 2022-23 and 2023-24 will have to be submitted along with Technical Bid and photocopy of P&L Account and Balance Sheet for years 2021-22, 2022-23 and 2023-24 shall have to be submitted duly certified by the Chartered Accountant of the firm/agency.
- 3. The bidder should have sufficient inventory of specified items and is required to furnish undertaking of the same along with bid.
- 4. The bidder should have a minimum of three years experience in the same field with government or private sector institutions. A minimum of six work orders (average two for the year 2021-22, 2022-23 and 2023-24) should be submitted along with the bids.
- 5. The bidder should have filed Income tax return for the Assessment Years 2021-22, 2022-23 and 2023-24 and should have submitted ITR's accordingly.
- 6. The bidder should be Himachali bonafide. Preference will be given to the vendor of the district or nearby district where function will be organized.

Terms and Conditions:-

- 1. The bidder shall have to upload 'Technical Bid and 'Financial Bid'. The technical bid shall contain all the required documents such as copy of PAN Card, Aadhar Card, GST Registration No. including EMD as per Annexure "A". The financial bid envelope should contain the rates of items quoted as per Annexure 'B'. Both the bids should be uploaded separately.
- 2. The approved tender rates will be valid for two years from the date of issue of award letter.
- 3. The Bid should be submitted with EMD of Rs 25,000/- in the form of Demand Draft duly pledged in the name of Director, Information and Public Relations, Himachal Pradesh, Shimla-171002. EMD of successful bidder shall be retained as performance security till the completion of contract term.
- 4. No advance payment will be made to the firm. All/every payment will be released only after the satisfactory completion of the event duly certified by the authority for the purpose. All statutory deductions e.g. GST, TDS and IT. TDS etc, will be made from the due payment of the bill to the bidder.
- 5. Payment of the firm can be made only as and when fund or budget will be available with quarter concerned. No advance payment will be made.
- 6. All rates should be quoted inclusive of GST.
- 7. The agency should have well established warehouse in the State of Himachal Pradesh.
- 8. The payment of services provided will be made for the day on which actual service is taken. No payment will be given for the days in which preparation is done.
- 9. The rates quoted shall be inclusive of transportation, loading/unloading of all items.
- 10. The items should be clean and in good condition. Torn or mutilated articles will not be accepted.
- 11. The bidder must have experience to hold large events.
- 12. The bidder will have to maintain satisfactory cleanliness at the spot.
- 13. The Departments will bear/own no responsibility for any damage and or loss to the articles provided during transit and/ or their use by whatsoever means and to whatsoever extent.
- 14. The bidder will ensure that there is no loss to property/life due to the articles provided and/ or served. He will be responsible for any type of loss.
- 15. No inflammable material will be used for the construction of stage and other allied items.
- 16. This will be the sole responsibility of the agency/ firm that the manpower supplied is not engaged in any criminal activity. The firm must check the character antecedents of the same.
- 17. It will be the responsibility of the successful bidder to follow the provisions of labour laws and other relevant laws.
- 18. Permission required for transportation of items etc. at the place of event is to be obtained by the agency as and when required from the Government.
- 19. The successful bidder is required to enter into a contract agreement with the undersigned within ten days of issuance of offer letter failing which his/her EMD will be forfeited in favour of Director, Information and Public Relations, Himachal Pradesh, Shimla-171002.
- 20. The technical bids shall be opened first. The financial bids of the bidders qualified in technical bids shall only be opened.
- 21. The bidder must supply documents in support of his experience during the last three years in Tent Services in Government or private sector institutions.

- 22. The bidder must ensure proper fire fighting arrangement.
- 23. The Total rates quoted shall be inclusive of all taxes and FOR at any location.
- 24. The bidder is required to quote rates for each item and sub-items, otherwise the bid will be rejected. However, the bid will be evaluated on total cost basis.
- 25. The empanelment of Agencies/Firms, rates will be finalized on L-1 basis after negotiation for each item.
- 26. For empanelment of the Agencies/ Firms matching option will be given to Agencies/ Firms on basis of L-1 rates to enter in the contract agreement with the department for empanelment.
- 27. Director, Information and Public Relations. H.P reserves the right to empanel one or more agencies/ firms for speedy execution of work.
- 28. The distribution of work amongst empanelled Agencies/Firms will be the sole discretion of the hiring Departments on the basis of capacity, performance to meet out exigency of work and past experiences.
- 29. If the services provided by the successful Agency/Firm are not found/ reported to be not as per the specifications, the hiring Departments can hold the bills submitted by the Agency/Firm, or not make any payments. For any serious lapses or fraudulence on the part of Agency/ Firm, contract may be cancelled and performance guarantee pledged in the name of Director, Information and Public Relations HP will be forfeited in favour of the Government. The firm can be blacklisted.
- 30. The successful bidder will have to abide by all the instructions/ guidelines issued by the Hon'ble Courts and regulating authorities from time to time.
- 31. The successful bidder agency shall be responsible to ensure all Indian Safety Standards. The bidder shall ensure structural safety, fire safety, proper ventilation, safe electricity supply and other safety measures.
- 32. No subletting will be authorized. The Agency/ Firm will be responsible for the execution of whole work itself.
- 33. The undersigned reserves the right to modify, relax, wave off, accept or reject any term & condition of bid/tender without assigning any reason thereof.
- 34. All the disputes are subject to the jurisdiction of Himachal Pradesh High Court, Shimla only.
